Within fifteen years from date of purchase Project Cürv will repair or replace the heater element where the fault is due to defects in materials or workmanship. All electronic components of this heater will be replaced within the first five years from purchase in event of failure. In the event of a warranty claim please consult your local dealer and return the heater together with proof of purchase.

A prerequisite for validity of the warranty is use at the specified supply voltage of the heater and use in accordance with the conditions specified in this manual. (Any further warranty or claims are excluded.)

Failure to register your warranty as per above will result in a twelve month warranty being granted for all components of the heater.

Cürv Smart products require a WiFi enabled (2.4Ghz protocols 802.11b/g/n) router and internet connection to access the smart hub.

Cürv cannot be held responsible for the quality or consistency of your internet connection and faults should be addressed with your provider.

This Limited Warrantydoes not guarantee that the use of the Cürv Smart products will be uninterrupted or error free.

The warranty covers the repair or replacement of the defective product only and Project Cürv shall have no liability for installation costs or consequential losses however incurred.

Removing the serial number will void the warranty. The warranty will also be void if the heater has been tampered with or opened in any way.

The product identification label must be left on the panels where they can be accessed after installation if nessessary.

Project Cürv will assume no responsibility for scratches on surface after first use.

Project Cürv cannot accept responsibility for damage, loss or injury caused by ingress of water or moisture, accidental damage, mishandling, external impact, adjustment by authorised personnel or failure to follow the correct maintenance and safety precautions as stated in the manual. WHAT THE WARRANTY COVERS

For a period of (* see above products) year from the date of purchase of your Cürv product, Curv360 Limited ("Cürv") will, at its sole option, repair or replace any Cürv products that malfunction due to defective parts or workmanship at no charge to you. This warranty is not transferable and applies only to the original consumer purchaser. Cürv may, in its sole discretion, make any repair or replacement with new or refurbished product or components. If the product or component requiring repair or replacement is no longer available, Cürv may, in its sole discretion, replace such product with a similar product of similar function.

WHAT THE WARRANTY DOES NOT COVER

Repair service, damage due to misuse, abuse, negligence, or casualty (e.g., fire), acts of God (including but not limited to lightning, flood, tornado, earthquake, or hurricane), and consumable parts (including batteries) are not covered by this warranty. Damage from unauthorized service or modification of the product or of any furnished component will void this warranty in its entirety. This warranty does not include reimbursement for inconvenience, installation, loss of use, or unauthorized service. In addition, this warranty does not cover any losses, injuries to persons, loss of property or general damages. This warranty covers only Cürv products and is not extended to other equipment, components, or devices that a customer uses in conjunction with our products.
